**July 2009 Police Blotter**

***All Persons named are presumed innocent until proven guilty in a Court of Law***

***Incident/Charge: Attempted Murder; Burglary; Possession of Weapon by a Felon Arrest***

**On 07/08/2009** Justin Winters of Moonachie, NJ was arrested by Sgt. Schmidt, and P.O. DeTrizio. Justin Winters was involved in a verbal argument with the victim, whom he knew and then threatened that person with a knife. Winters allegedly put the knife to the neck of the victim, and then after being forced out of the home, he stabbed the door of the home several times. Mr. Winters was charged with several offenses including attempted murder, burglary, and possession of a weapon by a convicted felon. Det. Inserra assisted with the processing and bail was set at \$400,000.00 by a Superior Court Judge.

***Incident/Charge: Assault; Possession of a Weapon by Felon; Burglary Arrest***

**On 07/09/2009** John Wilkoski of Moonachie was charged with assault, burglary, possession of a weapon for unlawful purposes and possession of a weapon by a convicted felon. Mr. Wilkoski assaulted his friend after an argument. Bail was set at \$75,000.00 and at \$ 50,000, on the different charges. Several officers worked the case, including, Sgt. Dressel, Sgt. Millar, Det. Fugnitti. P.O. Bussanich and P.O. DeTrizio.

***Incident/Charge: DWI Arrest***

**On 07/11/2009** Sungkyu Chae of Lyndhurst, NJ was arrested for suspicion of driving under the influence of alcohol. Mr. Chae was arrested by Sgt. Behrens after a motor vehicle stop in the Teterboro area. Mr. Chae was processed and issued summonses at the Moonachie Police Department. A relative responded to headquarters and drove Mr. Chae home when he was released, his vehicle was impounded.
